



## **NOTIFICATION**

### **Admission on ONE residual vacant seat of MBBS course (2018-19) in Mahatma Gandhi Medical College, Jaipur**

It is informed to all concerned that after the Mop-up round of seat allotment by the NEET UG Medical and Dental Admission/Counseling Board-2018 on August 21 & 22, 2018 and on the expiry of the reporting date of candidates to the allotted colleges/institutions on 26.08.2018, **ONE (01) seat** of MBBS course (unreserved category) has remained vacant in Mahatma Gandhi Medical College, Jaipur.

Candidates desirous to seek admission on this residual vacant one seat of MBBS course in Mahatma Gandhi Medical College & Hospital, Jaipur are informed to report in the office of the Principal, Mahatma Gandhi Medical College & Hospital on **Wednesday, 29.08.2018 at 11:00 A.M.** along with all necessary original documents and prescribed fees as mentioned below. Admission shall be made strictly on merit basis from the Provisional Merit List (Mop-up round) 21.08.2018 provided by the NEET UG Medical and Dental Admission /Counseling Board-2018 which is available on – **[www.rajugmedical2018.org](http://www.rajugmedical2018.org)** and also on **[www.mgumst.org](http://www.mgumst.org)**

#### **Eligibility for admission –**

As laid down in the Notification/Instructions issued by the Rajasthan State NEET UG Medical and Dental Admission/Counseling Board-2018.

#### **Fees Structure**

##### **MBBS Course (4½ Years)**

Rs. 15 Lac (Rupees Fifteen Lac) only per annum at the time of admission. In addition, candidate will be required to deposit tuition fee for minimum next two years period of the course duration at the time of admission in the form of Cash security/Bank guarantee from a Nationalized Bank. Tuition fees and caution money shall be accepted through RTGS/Bank Demand Draft in favour of Mahatma Gandhi Medical College & Hospital payable at Jaipur.

#### **Bank Guarantee/Bond for fees**

Bank Guarantee for second year & third year - as per the proforma (**Annexure – 1**).

Bond by the candidate and his/her Parents/guardians - as per the proforma (**Annexure – 2**).

**The candidate selected for admission on the vacant seat shall be required to deposit tuition fees, caution money and bank guarantee as mentioned above latest by 5:00 P.M. on Wednesday, 29.08.2018 failing which his/her claim for admission shall stand cancelled and next eligible candidate in merit will be given offer for admission.**

**Documents (in original) required at the time of Reporting on Wednesday, 29.08.2018 at 11:00 A.M.**

1. Proof of registration with the Rajasthan State NEET UG Medical and Dental Admission/Counseling Board-2018.
2. Proof of name in the list of the candidates eligible for Mop-up round of counseling conducted by the NEET UG Medical and Dental Admission/Counseling Board-2018 on August 21 & 22, 2018.
3. NEET 2018 Score Card.
4. Mark sheet of 10+2 (Senior Secondary) Examination or its equivalent.
5. Mark sheet of secondary examination (10th class) showing date of birth.
6. Character Certificate
7. Transfer Certificate (School leaving certificate)
8. Migration Certificate
9. Copy of photo ID (driving licence/PAN card/Voter ID/Govt. or PSU card/School ID card / 12th class examination admit card/Aadhaar card).
10. 4 Passport size photo.
11. Bond as per the applicable Proforma.
12. Any other relevant certificate(s)

The jurisdiction of all disputes in relation to the matters pertaining to this admission shall be the Jaipur Bench of Hon'ble Rajasthan High Court only.

**Guide Lines for BG preparation.**

1. BG will be made on Non Judicial stamp paper from any nationalized bank.
2. Students may give separate Bank Guarantee for the fee of II and III year.
3. Bank authorities will give BG Number and will sign on each page.  
Minimum two Bank official signatories, who are authorized to sign, will sign the Bank Guarantee.
4. Bank authorities will forward the BG to Mahatma Gandhi Medical College and Hospital, Sitapura, Jaipur under a proper covering letter.
5. In case of any deviation from above, BG will not be accepted.

*Sample Format*

**BANK GUARANTEE**

(To be provided on Non Judicial stamp paper)

1. In consideration of the Mahatma Gandhi Medical College & Hospital (MGMCH), Jaipur, a private Medical College (hereinafter called "College") having agreed to provide admission in MBBS Course to Mr./Miss.....  
S/o, D/o ..... (hereinafter called "the said student"), a Bank Guarantee for performance of payment of the annual fees for remaining years of course payable by the said student is required.
2. We ..... (Name & Branch of Bank) (hereinafter referred as "the Bank") at the request of ..... (the said student) do hereby undertake to pay the college an amount not exceeding Rs. 30,00,000/- (Rupees Thirty lac only) against dues of annual fees payable to the college by the said student for second and third year for MBBS. course under any of the following circumstances -

(a) When student fails to deposit the regular annual fee in the time-frame before last date of payment prescribed by the MGMCH, Jaipur as detailed below : -

(b) When student has discontinued and not pursuing his / her studies due to any reason whatsoever, the entire fee for remaining years will be immediately payable to MGMCH, Jaipur.

(c) When student has been rusticated due to misconduct or any disciplinary action or criminal act on his part, the entire fee for remaining years will be immediately payable to MGMCH, Jaipur.

The fees will be paid on due dates as mentioned above, failing which the Bank Guarantee will be encashed by the college.

3. We, the .....(Name & Branch of Bank) do hereby undertake to make part payment also in each year (when required) against this guarantee as and when demanded by MGMCH.
4. We, the .....(Name & Branch of Bank) do hereby undertake to pay the amount due and payable under this guarantee without any demur merely on a demand from the college stating that the amount claimed is due to the said student. Any such demand made by the college on the Bank shall be conclusive as regards the amount due and payable by the Bank to the College under this guarantee. However, our liability under this guarantee shall be restricted to an amount not exceeding Rs. 30,00,000/- (Rupees Thirty lac only).
5. We undertake to pay to the MGMCH, Jaipur any money so demanded notwithstanding any dispute or disputes raised by the student in any suit or proceeding pending before any court or Tribunal relating thereto, our liability under this present being absolute and unequivocal. The payment will be made by us to MGMCH and the student shall have no claim against us for making such payment.
6. We, the ..... (Name & Branch of Bank) further agree that the guarantee herein contained shall remain in full force and effective during the period that would be taken for the performance of the said Admission and that it shall continue to be enforceable till all the dues of MGMCH under or by virtue of the said Admission have been fully paid and its claims satisfied or discharged or till 31<sup>st</sup> Aug. 2020 and the college certifies that the terms and conditions of the said Admission have been fully and properly carried out by the said student and accordingly discharge this guarantee.
7. The Bank Guarantee shall remain in force up to 31<sup>st</sup> May. 2020. Unless a claim is lodged with the bank within three months from the said date i.e. by 31<sup>st</sup> Aug. 2020, this guarantee shall be forfeited and the Bank shall be relieved and discharged for all liabilities there under.
8. This guarantee will not be discharged due to the change in the constitution of the bank.
9. We the ..... (Name & Branch of Bank) lastly undertake not to revoke this guarantee during its currency except with the previous consent of MGMCH in writing.
