Minutes of the Fiftieth meeting of the Academic Council held on March 11, 2025

Fiftieth meeting of the Academic Council was convened on March 11, 2025 at 11:30 A.M. in the Board Room, 5th Floor, R.K. Academic and University Block under the Chairmanship of Dr Achal Gulati, President, MGUMST.

List of the members who participated in the meeting is appended as **Annexure-1**. Member of the Council namely - Dr Anil Suri and Special Invitee - Dr Hari Gautam joined the meeting online.

The Chairman at the outset of the meeting welcomed all the esteemed members and Special Invitees attending the meeting online and in person. Before taking up the agenda items, the Chairman informed the Council about the sad demise of Padmashree Dr R.P. Soonawala, Founder Chairperson of the MGUMST on 04.01.2025 and Dr Munish Kakkar, Professor of Paediatrics & Additional Principal, MGMCH and Proctor, MGUMST on 16.01.2025. The Council observed one-minute silence to mourn the demise of these persons and prayed for tranquility of the departed souls.

After a short break, the Council resumed its meeting. The Chairman acknowledged and appreciated the contribution made by the members and special invitees in the academic growth of the University. - ii) the order dated 24.02.2025 approving Admission Notification 2025-26 for Masters in Hospital Administration (MHA).
- 4. The Council considered and approved the recommendations of the Board of Research made at its meeting held on 03.03.2025. The Council appreciated the work done by the Research Board and put on record the same and also the efforts made by Dr Nikhil Marwah, Dean, Research, MGUMST, Dr Richa Sharma, University Coordinator for Ph.D. program and Dr Shikha Mathur, Professor, Physiology, MGMCH in organizing Research Combined Round (RCR) for improvement in the quality of research. The role of Artificial Intelligence (AI) in research was considered by the Council. Few members of the Council expressed their views to the effect that AI usage in writing the thesis/articles may hamper the creativity of scholars, hence may not be allowed at present. The Council after deliberating upon the issue resolved that the Chairman, Board of Research may constitute a committee to explore the possibilities of involvement of AI in research taking into consideration its pros and cons and future prospects.
- 5. The Council considered the request of the Dean, Faculty of Medicine to appoint Dr Basant Kumar Chaudhury, MD, DMRD, MRCP (UK), FRCP (Edinburgh), FRCP (London), Adjunct Professor of Medicine, Faculty of Health and Medical Sciences, Symbiosis International (Deemed University), Pune and Consultant Physician & Gastroenterologist, University Hospital of North Tees, UK as honorary Adjunct Professor in the discipline of Medical Gastroenterology.

Considering Dr Basant Kumar Chaudhury an accomplished professional/expert in the field of Medical Gastroenterology, the Council recommended to appoint him as honorary Adjunct Professor in the discipline of Medical Gastroenterology.

- 6. The Convener, Admission and Career Counselling Cell apprised the Council about admission plan and progress for the academic year 2025-26. He placed draft Notification for admission (2025-26) before the Council. The Council deliberated upon the notification.

The Dean, Faculty of Nursing submitted and proposed that admissions to nursing programs for 2025-26 may be made through MGUMST entrance test as the State Government is not conducting entrance test for admissions to nursing programs in the MGUMST. The same was done last year also. The Council accepted the proposal of the Dean, Faculty of Nursing as above.

Regarding admissions in Clinical Psychology program (2025-26), the Chairman informed the Council that he has had interactions with RCI, New Delhi officials on 10.03.2025. He informed that RCI Portal is currently open for obtaining permission to offer various clinical psychology programs for academic year 2025-26. The Council resolved that the MGMCH should apply to RCI without delay for clinical psychology programs 2025-26. Other permissions as required from various departments of the Rajasthan Government may also be obtained by the Principal in time. Notification for
