**Minutes of the Fifty-first meeting of the  
Academic Council held on May 01, 2025**

Fifty-first meeting of the Academic Council was convened on May 01, 2025 at 11:30 A.M. in the Board Room, 5<sup>th</sup> Floor, R.K. Academic and University Block under the Chairmanship of Dr Achal Gulati, President, MGUMST.

The Chairman at the outset of the meeting welcomed all the esteemed members and Special Invitees attending the meeting online and in person. - ii) In order to decide whether M.Sc. (Medical) programs be conducted annually or semester wise, a Committee of the following is constituted:

Heads of the Departments of Anatomy, Physiology, Biochemistry, Microbiology, Pharmacology, MGMCH	-	Member

Dr Bushra Fiza, Professor of Biochemistry, MGMCH and Dean, Faculty of Paramedical Sciences, MGUMST	-	Member Secretary

The Committee shall submit its recommendations within a week to the President, whose orders shall be final and reported to the Council at its next meeting.

- iii) The list of Post Doctoral Certificate Courses (PDCC) and Post Doctoral Fellowship (PDF) be accepted and the Dean & Principal, MGMCH be requested to take further necessary actions regarding permission from the National Medical Commission (NMC) to start these programs. After receiving necessary permission from the NMC, the Board of Studies in Super Specialty Courses shall initiate the matter for offering the permitted courses for admissions.
6. The Director, Internal Quality Assurance Cell (IQAC) presented the progress made by IQAC, MGUMST before the Academic Council. He informed that meetings of Committees of Courses and Boards of Studies are being conducted regularly. Number of applications for admission in University run programs have substantially raised, showing a high student demand ratio. Mentor Mentee programs is being stringently followed across all the constituent colleges of the University. There is regular conduction of Basic Course in Medical Education under NMC approved Regional Centre of Medical Education and Technologies (MET). Examination reforms in the form of Objective Structured Clinical Examination (OSCE) and Objective Structured Practical Examination (OSPE) have been initiated in internal assessments.

There is substantial increase in number of research papers published, awards and achievements of the faculty members, number of startups and innovations in the University. The University has initiated the process of giving scholarship to the meritorious students. There is substantial increase in capacity enhancement and skill development programs benefitting the students. There has been increase in the number of placements and students progressing to higher education across all constituent colleges of the University. Effective welfare measures are being provided by the University for teaching and non-teaching staff. Faculty development programs are being conducted regularly and there is substantial increase in number of teachers undergoing these programs. 7. The Convener Admission and Career Counselling cell, MGUMST apprised to the council regarding the progress made by the admission cell in admission process for 2025-26. He informed that the first round for admissions in MHA program has been completed.

The Convener informed that the notification for various UG and PG Degree/Certificate programs has been prepared and as per orders of the President the same is placed before the Council for consideration.

During consideration of the Notification, the Dean & Principal, MGPC requested to enhance seats in BPT program from existing 80 to 125 w.e.f. 2025-26. The Council, in principle, accepted the request of the Principal, MGPC to enhance seats in BPT program from existing 80 to 125 w.e.f. academic year 2025-26. However, admission notification, as placed in the meeting by the Convener, Admission and Career Counseling Cell shall be issued for 80 seats. It may be revised by the University after obtaining permission of 125 seats by the Principal, MGPC from Competent Body and thereafter approval of the President.

The Council after making minor amendments approved the Admission Notification (**Annexure-4**).

He further informed that the Admission Cell shall be conducting University Placement Drive for all constituent colleges of the university on 17<sup>th</sup> May, 2025. The top Hospitals and Healthcare Companies are likely to participate in the event. He also informed that the Admission Cell is going to participate in "The Dainik Bhaskar Education and Career Fair" from 2<sup>nd</sup> May to 4<sup>th</sup> May, 2025. It will represent the university to cater various UG and PG aspirants visiting in the Fair.

### Items with the permission of Chair

8. The Deans of the Faculties attending the meeting submitted that necessary amendments have been recommended by their respective Faculties in the syllabuses of various programs for the academic year 2025-26 which are based on the recommendations of respective Boards of Studies/Committees of Courses. These amendments/changes have already been recorded in the minutes of the Faculties. The Deans submitted that the syllabuses in which the respective Boards of Studies/Committees of Courses have not recommended any change, be accepted by the Council for the academic year 2025-26. The Council resolved to accept the submission of the Deans as above.
9. The Dean and Principal, MGMCH submitted that the Academic Council in its meeting held on December 20, 2024 had resolved to establish a separate "Centre for Yoga, Wellness and Integrative Medicine" in the Mahatma Gandhi Medical College & Hospital in place of the "Department of Wellness, Naturopathy and Yogic Science" of the Mahatma Gandhi Institute of Allied Health Sciences (MGI AHS) and further that the students already admitted and studying in B.Sc.

and M.Sc. Yoga Therapy in the Mahatma Gandhi Institute of Allied Health Sciences would continue to remain the students of the MGIAHS.


He proposed that in order to expand the programs related to Yoga, Wellness and Integrative Medicine, a separate Institute – “Mahatma Gandhi Institute of Yoga and Integrative Medicine” (MGIYIM) may be established in due course of time when infrastructure and other facilities are properly evolved. M.Sc. and B.Sc. Yoga Therapy programs being conducted in MGIAHS may be shifted in this Institute after its proper establishment. All the programs related to yoga and integrative medicine subjects may be listed under the Faculty of Medicine and Surgery.

The Council after due deliberations resolved to accept the above proposal of the Dean, Faculty of Medicine and Surgery in principle.

10. The Council observed that the schedule of the meetings as already prepared by the Academic Council in its meeting held on December 20, 2024 is not being sincerely adhered to. The Chairman advised that the Deans and Conveners must heed to the already decided schedule of meetings in future. Sufficient time should be given in issuing notice & agenda and circulation of minutes of the meetings in future.
