



Minutes of the Fifty-second meeting of the Academic Council held on August 30, 2025

Fifty-second meeting of the Academic Council was convened on August 30, 2025 at 11:30 A.M. in the Board Room, 5th Floor, R.K. Academic and University Block under the Chairmanship of Dr Achal Gulati, President, MGUMST.

appointment of Dr Sandeep Narula, Professor, MGCOHA as Centre Head, the Principal, MGCOHA in the meeting, requested the Council to further consider the name of the Centre as the "**Centre of Health Management Excellence**". The Council resolved to accept this request of the Principal, MGCOHA.

- ii) Dated 11.07.2025 regarding establishment of "**Centre of Excellence for Hemoglobinopathies and Hematological Diseases & Research (CEHDR)**" under Mahatma Gandhi Medical College & Hospital and appointment of Dr Rachna Narain, Professor & Head, Department of Immunohematology and Blood Transfusion as Centre Head.

The Council also resolved that the present practice of putting **Ms.** before the names of female students in their marks sheets, tabulation registers and other record of the university be discontinued. All students be enrolled in the MGUMST with the same details as appearing in the marks sheets/degrees/certificates of their qualifying (10+2/graduation/post-graduation, as the case may be) examination.

4. The Director, IQAC informed that as per the communication received from the National Assessment and Accreditation Council (NAAC) on 22.08.2025, HEIs are not constrained to submit Annual Quality Assurance Report (AQAR) at the end of the year. Non-submission of AQAR shall not restrict the HEIs for Maturity Based Graded Level (MBGL) or Binary Accreditation Framework (BAF). However, they shall keep up their effort towards continuous quality improvement measures and shall record the same through their IQAC. He further informed that NAAC is in the process of improvising mechanisms for capturing progress in the HEIs.

He apprised the Council about the progress made by the IQAC during last four months as under:

MGMCH has been recognized as 1st and only Academic Medical Centre by the Joint Commission International. Criteria wise progress was explained.

Criteria 1: Course work, curriculum and academic calendar of PhD has been streamlined. Meetings of Boards of Studies and Committee of Courses have been conducted regularly. MBBS, MD/MS and DM/MCh curricula have been revised and Swayam course has been introduced in University run programs.

Criteria 2: Substantial increase in number of admissions and Regular conduction of workshop of MET.

Criteria 3: Substantial increase in number of publications, patents and copyrights.

Criteria 4: New academic building of MG Nursing College and Construction work of 2 Silver Jubilee towers is going on full swing.

Criteria 5: Regular conduction of Students Council activities, Wall magazine and Newsletter have been released.

Criteria 6: Regular conduction of meetings of various Committees and Cells.

Criteria 7: Substantial increase in number of kidney/liver transplants and Regular conduction of Skill enhancement programs. It was also informed that Professor Ram Mohan Jaiswal, Department of IHBT, MGMCH has been given the responsibility to take care of this Criteria.

The Council noted the progress made by the Internal Quality Assurance Cell (IQAC) as explained by the Director, IQAC as above and resolved that the IQAC must continue to make all efforts and ensure for persistent quality improvement measures by the Institute.

The Chairman requested all the Principals to ask their HoDs to make more efforts for achieving higher standards of education and research and accordingly provide relevant data to the IQAC regularly. This will also help in providing information for National Institutional Ranking Framework, Joint Commission International etc.

The Convener apprised the Council about the admissions made so far in various programs in the MGUMST for the academic session 2025-26 (**Annexure-3**). He informed that process of admissions to Ph.D. program is being started soon and for the following courses, the process will be started after receiving necessary permissions from the Government/Respective Councils:

- i) Allied and Healthcare graduate level courses.
- ii) Clinical Psychology courses.

The Convener, Admission and Career Counselling Cell presented before the Council draft notification for admissions to Allied and Healthcare graduate level courses carrying process of admission to 10 courses through MGUMST entrance test, number of seats, eligibility, tuition fees & other charges etc.

The Council noted the progress of admissions as presented by the Convener, Admission Cell and approved the above notifications. It also approved the draft notification for admission to Allied and Healthcare graduate level 10 courses for the academic year 2025-26 with the resolution that the notification be issued soon after receiving communication from the RSAHC in this regard.

6. The Council was apprised about the परिपत्र क्रमांक राज.स्टेट.अ.हैल्थकेयर कॉ./ मान्यता/2025/294 दिनांक 17.07.2025 issued by the Rajasthan State Allied and Healthcare Council (RSAHC), Jaipur. The RSAHC has informed that under the provision of the National Commission for Allied and Healthcare Professional Act, 2021, the RSAHC has been constituted by the Government of Rajasthan Medical and Health (Gr-3) Department on 30.08.2024. The RSAHC vide its above said circular has desired certain information from the MGUMST including documents regarding necessary permissions for conducting physiotherapy courses.

It was informed that the University through its letter no. MGUMST/Academic/ 2025/4492 August 22, 2025 to the RSAHC has sent copy of necessary permissions granted by the Academic Council for number of seats in BPT and MPT programs along with the list of students admitted to these programs in the academic year 2025-26.

The Council noted and approved the action taken by the University as above.

7. The Council considered and approved the recommendations of the Board of Research made at its meeting held on August 28, 2025.

The Dean, Research and Member Secretary, Board of Research apprised the Council about the recommendations made by R&D Cell, IIC, Publication Committee, IPR and IIP cell in respect of academic & research grants 2025-26, MoUs made, Research Combined Rounds (RCR) and Ph.D. rules and

regulations. While approving these recommendations, the Council asked the Dean, Research to present a report on proposed-amendments in MGUMST Ph.D. rules and regulations (2025-26) in light of UGC regulations-2022 to the President for consideration and approval. Clarification may be sought by the MGUMST from the UGC/NMC wherever deemed necessary. The Council further resolved that the list of eligible Ph.D. guides as received from the Principals may be screened by the Dean, Research in consultation with the HR department and submit it to the university office for further needful.

8. The Council considered examination regulations of the Indian Nursing Council issued vide Notification-7 of 2025 no. F.No.1-6/B.Sc.(N)/2025-INC dated 13.08.2025 regarding check points for appearing at B.Sc. Nursing semester examinations and resolved that these regulations be implemented with immediate effect. The Council also considered and approved amendments in already issued office order no. MGUMST/Acad/2025/4242 dated May 14, 2025 regarding reforms in supplementary examinations in semester wise programs including nursing programs. Amended reforms in supplementary examination in semester wise programs including nursing programs are annexed as **Annexure-4**.

9. The Council considered the matter of criteria for awarding Gold Medals/ Certificate of Excellence in the forthcoming University Convocation.

It was resolved that the Chairman may constitute a committee for the purpose. The committee may submit its recommendations to the President for approval.

10. The Council was apprised about the adoption of the Term 'Allied and Healthcare' in place of 'Paramedical' as per Circular no. F.No.Z/103/2024-AHS-DOHFW (FTS-8309547) dated July 01, 2025 issued by the National Commission for Allied and Healthcare Profession (NCAHP), Ministry of Health and Family Welfare, Government of India.

After due deliberations, the Council, to align with the regulations of the NCAHP, in principle, agreed and decided that as and when the situation may warrant, following resolutions be made effective:

A. Existing Faculties, Boards of Studies and Committees of Courses, as under, be dissolved:

- ii) Faculty of Paramedical Sciences
- iii) Board of Studies in Physiotherapy
- iv) Board of Studies in Paramedical Sciences

- vii) Committee of Courses in Health Informatics

- B. A new Faculty – “Faculty of Allied and Healthcare Profession” be created.
- C. Following Boards of Studies under the new “Faculty of Allied and Healthcare Profession” be created:
 - i) Board of Studies in Physiotherapy
 - ii) Board of Studies in Occupational Therapy
 - iii) Board of Studies in Allied Health Sciences
 - iv) Board of Studies in Health Informatics and Biotechnology
- D. Appointment, powers and functions of the Dean of the Faculty shall be as laid down in the relevant Section(s) of the Act and Statutes of the MGUMST.
- E. Composition, constitution, powers and functions of the aforesaid Faculty and Boards of Studies shall be as laid down in the relevant Statutes of the MGUMST.
- F. Subjects to be brought under the above Boards of Studies be recommended by the Dean of the Faculty and the Conveners of the Boards of Studies for approval of the Academic Council.
- G. Information regarding dissolution/creation of the above said Faculty, Boards of Studies and Committees of Courses be sent to the Higher Education (Gr-IV) Department by the MGUMST.
- H. The Council also considered the matter of nomenclature of Boards of Studies under the Faculty of Medicine and Surgery and resolved that nomenclature of BOS in non-clinical subjects be changed to BOS in pre-clinical subjects as all the non-clinical subjects have been considered as pre-clinical subjects by the NMC.

Items with the permission of Chair

11. Admissions to Hospital Administration program.

Dr Tanjul Saxena, Principal, Mahatma Gandhi College of Hospital Administration (MGCOHA) submitted that the Masters in Hospital Administration (MHA) program is being conducted in MGCOHA semester wise. Candidates desirous to seek admission in this program come from various streams. Results of their qualifying examinations and/or national/state level entrance tests are declared in different months. As such, many eligible students remain unable to apply for admission in MGCOHA for MHA program. She requested the Council that instead of admitting only one batch of students in a year and starting their classes in July, the MGUMST may admit two batches of students in a year and start their classes of first semester in July and January every year.

The Council considered the request made by the Principal, MGCOHA as above and resolved to accept her request, in principle, to admit students in two batches and commence their classes in July and January every year.

Before making request to the MGUMST for admitting second batch of students in MHA first semester, she must ensure availability of adequate faculty members, class rooms and other necessary infrastructure.

12. The Council considered the academic calendars (2025-26) presented by Principals of university constituent colleges/institutes and approved the same.

13. Over view of the academic activities: presentation by the Dean, Academics

Dr Archana Paliwal, Dean, Academics presented before the Council an overview of the academic activities undertaken by the MGUMST during past and the current academic years.

She informed that with a primary objective to create a platform for students at all levels to develop critical thinking, scientific writing and presentation skills and further in order to promote **interdisciplinary learning** and strengthen the **academic and research culture** in the institution, structured series of academic activities in the form of Under Graduate Combined Rounds (UGCR)/Post Graduate Combined Rounds (PGCR)/Research Combined Rounds (RCR)/Dental Combined Rounds (DCR)/ Physiotherapy Combined Rounds (PCR)/Nursing Combined Rounds (NCR)/Health Informatics and Management Combined Rounds (HIMCR) etc. have been introduced. These activities have significantly boosted the confidence of the students and faculty-student academic interaction. The MGUMST, till now, has witnessed 40-DCRs, 25-PGCRs, 17-UGCRs, 19-PTCRs, 24-NCRs, 6-HIMCR and also 20-RCRs.

Recently, an MOU with Hasselt University, Belgium has been signed. Hasselt University has identified 8 students who will be coming for observer ship in MGMCH in March, 2026. One student Nundini from San Diego University California will also join medical oncology department in Nov., 2025 for pursuing her research project “Sex education, HPV Vaccination and Cervical cancer”.

Publication of a booklet based on 50 sessions of “Jaipur Swasthya Charcha”, (A series of sessions taken by the expert faculty members for the community regarding common health problems) is expected soon.

She also explained about the activities carried out by the students, faculty members, staff and alumni of the MGUMST. These activities included demonstration of vibrant cultural and creative engagements – Basant, Painting Smiles, Research Arc, Aarav, Turncoat, Tarang, Marauder’s Mayhem, Utsav and International Clinical Trial Day. The academic and awareness initiatives undertaken included Anti Ragging Week, Newsletters and Pratibimb – The Wall Magazine.

The Council noted the academic activities as explained by the Dean, Academics as above.
