In compliance of orders of Hon'ble Supreme Court of India dated 24.12.2020
in SLP No. 15950/2020

Deposition of cash security/bank guarantee by all concerned students/candidates who have taken admission in MBBS course- 2020-21 in Mahatma Gandhi Medical College & Hospital, Jaipur

It is informed to all concerned students/candidates and their respective parents/guardians that the Hon'ble Supreme Court of India vide its interim order dated 24.12.2020 in SLP No. 15950/2020 titled American Institute of Medical Sciences & Others V/s. Deepesh Singh Beniwal and Others has stayed the operation of the interim order dated 17.12.2020 passed by the Hon'ble Rajasthan High Court at Principal Seat Jodhpur in D.B. Civil Writ Petition No. 13535/2020 whereby it restrained for insisting upon furnishing of bank guarantee by the students who have taken admission/granted admissions to MBBS course on liberty to furnish bonds only towards the fee of remaining 3½ years in lieu of bank guarantee and on deposit of the full fee for the first year alone.

It is informed further that in compliance and in pursuance of the said order dated 24.12.2020 passed by the Hon'ble Apex Court all concerned students/candidates are required to deposit the cash security or furnish bank guarantee accordingly for remaining period of 3 ½ year course of MBBS, however, taking lenient view and balancing consideration as against final 1 ½ year of the course, the concerned students/candidates may give post dated cheques so as to enable them to manage the cash security/bank guarantee only for two years.

Under these facts and circumstances and in view of the interim order passed by the Hon'ble Apex Court on 24.12.2020 in SLP No. 15950/2020, all the students concerned and their respective parents/guardians are instructed and directed specifically to deposit the cash security/ bank guarantee only for the next remaining two years of the course of MBBS as against tuition fee amounting to Rs. 30 lacs (Rs. Thirty Lacs only) (State Quota seats) and Rs. 53.50 lacs (Rs. Fifty Three Lacs Fifty Thousand only)(Management Quota seats) besides having liberty to give post dated cheques for final 1½ year

course or alternatively to deposit the cash security/bank guarantee for the remaining entire 3½ course to the tune of Rs. 52.50 lacs (Rs. Fifty Two Lacs Fifty Thousand only) (State Quota seats) and Rs. 93,62,500/- (Rs. Ninety Three Lacs Sixty Two Thousand Five Hundred only) (Management Quota seats) latest by Wednesday, December 30, 2020 upto 4.00 PM in order to ensure and secure the admission and respective allotted seats in Mahatma Gandhi Medical College & Hospital, Jaipur. Further on failure to deposit cash security/bank guarantee and to give post dated cheques as instructed/directed the name of such students/ candidates and consequent details of fresh vacancy position shall be communicated to the Chairman NEET UG Medical/Dental Admission/Counseling Board-2020 for allotting other students in their place on seats fallen vacant due to such failure and non-deposit of cash security/bank guarantee/post dated cheques.
