Important Instructions –

Before coming to attend the Interview & Viva-Voce, candidates are advised to self-check and ensure their eligibility for admission to the Ph.D. Program. Candidates who do not fulfill the eligibility shall not be allowed to appear before the Admission Board. Candidates whose results of the qualifying examination are still awaited, shall not be allowed to appear before the Admission Board. **Following relevant Original documents and one set of self-attested photocopy of the documents** are to be brought by the candidate at the time of Interview & Viva-Voce otherwise the candidate shall not be allowed to appear for the Interview & Viva-Voce :

- Marks sheet/Certificate of the Secondary Examination (10th Class) showing date of birth.
- Marks sheet of 10+2 (Senior Secondary) or its equivalent Examination.

Marks sheet of M.Phil. (Nursing) examination and Papers published/accepted for publication in National/International Journals (for the candidates seeking admissions to Ph.D. nursing course).
 - Valid Certificate for Reservation Category (EWS/SC/ST/OBC-NCL/MBC-NCL etc.) if category is other than General Category.
 - No objection certification/permission from the present employer for the applied regular program (for in service candidate only). Without proper written permission for regular Ph.D. course from the present employer (from the concerned Dean, in case of MGUMST employees), their candidature shall not be considered and accordingly they will not be allowed for the Interview/Viva-Voce (Format annexed).
 - Transfer Certificate from the Institute last attended.
 - Character Certificate from the Head of the Institute last attended.
 - Copy of Aadhar Card.
 - Other relevant certificate(s), if any.
3. The Admission Board shall verify all the original documents necessary to determine eligibility for admission to Ph.D. program. The Admission Board shall take into account-performance of the candidate both in written test and interview/viva-voce for his/her admission.
 4. In-service candidates shall be required to submit written permission from their present employer for doing the course. Without proper permission from the employer applicant's candidature shall not be considered.
 5. Candidates selected by the Admission Board for admission shall be required to deposit prescribed fee as already mentioned in the University Notification dated July 26, 2022, which is available on the University website.
 6. No separate intimation shall be given to the candidates regarding interview & viva-voce examination or fee deposition schedule.
 7. In case, it is found that a candidate does not fulfill the conditions of eligibility prescribed as per the Notification/Rules, the University shall cancel his/her admission at any stage.
 8. Candidates shall have to abide by all rules/regulations of the University.
