Admissions to MBBS and BDS courses (2024-25) in Mahatma Gandhi Medical College & Hospital, Jaipur and Mahatma Gandhi Dental College & Hospital, Jaipur

It is notified that admissions on all the seats of MBBS and BDS courses respectively in Mahatma Gandhi Medical College & Hospital and Mahatma Gandhi Dental College & Hospital, Jaipur for the academic year 2024-25 shall be made from amongst NEET UG-2024 Qualified candidates through the NEET UG Medical & Dental Admission/Counseling Board-2024 constituted by the Directorate of Medical Education, Government of Rajasthan.

The process of admission/counseling will be as per Notification issued by the Chairman, NEET UG Medical & Dental Admission/Counseling Board - 2024. It is mandatory for a candidate to get himself/herself registered with the NEET UG Medical & Dental Admission/Counseling Board – 2024, otherwise he/she will not be eligible for participation in the process of admission to MBBS/BDS course in Rajasthan.

Eligibility –

Eligibility for admission to MBBS/BDS course shall be as laid down in the Notification/Information Booklet issued by the Chairman, NEET UG Medical & Dental Admission/Counseling Board – 2024.

1. State Quota seats are for Rajasthan State domicile candidates as per the eligibility given in the Information Booklet of the NEET UG Medical & Dental Admission/Counseling Board – 2024.
2. Management Quota seats are open for All categories (State Domicile and All India) Candidates.
