Notified Eligible Candidates Shortlisted for Counselling for Nursing Programs are required to appear in person before the Admission Board for **Verification of their Original Documents and Counselling.**

The Admission Board may offer Provisional Admission, strictly based on the availability of seats Category-Wise, as per the Reservation Policy of Government of Rajasthan.

Important Instructions:

Before attending the counselling, candidates are advised to self-check and ensure their eligibility in all respects for admission to the course they have applied for. Candidates who do not fulfill the eligibility shall not be allowed to appear before the Admission Board for the counselling. **Candidates whose results of the qualifying examination are still awaited, shall not be allowed to appear before the Admission Board.**

Other State candidates belonging to any reserved category shall be treated as General Category Candidate.

Following relevant **Original Documents** and **One set of Self-Attested photocopy** of the documents are to be brought by the candidate at the time of Counselling otherwise the candidate shall not be allowed for the Counselling.

- Marks Sheet/Certificate of the Secondary Examination (10th Class) showing Date of birth.
- Marks Sheet/Certificate of 10+2 (Senior Secondary) or its equivalent Examination.
- Marks Sheet of Qualifying Examination, as applicable (as mentioned in the "Eligibility" column of this notification)
- Migration Certificate if applicable.
- Domicile Certificate.
- Valid Certificate for Reservation Category (EWS/SC/ST/OBC-NCL/MBC-NCL etc.), if applicable.

EWS/OBC-NCL/MBC-NCL Certificate should not be older than 1 (One) Year.

The Admission Board shall interact with the candidates and may offer Provisional Admission.

Candidates found eligible for Provisional Admission by the Admission Board may be issued Provisional Admission Letter. Fees and/or postdated Cheque(s) as mentioned in the Provisional Admission Letter will have to be deposited by the candidate latest by June 27, 2026.

Fees as mentioned in the provisional admission letter should be deposited in the University Bank account through payment link sent to the registered email of the candidate.

Postdated cheque(s) of the amount as mentioned in the provisional admission letter and also as already notified in the admission notification dated 01.05.2026 will also be deposited by the candidate in the office of concerned Principal of concerned College up to the last date mentioned in the provisional admission letter.

In case a candidate does not Deposit Fees and/or Postdated Cheque(s) in time, provisional admission granted to the candidate shall stand cancelled and next candidate in waiting list shall be offered admission.

No extension of the last date of Deposition of Fees/Postdated Cheque(s) shall be granted in any case.

Required Undertakings/Declarations/Affidavits etc. shall be submitted in the Office of the Principal of the concerned College between June 27 to July 01, 2026.

NOTE

1. In case, it is found that a candidate does not fulfill the conditions of eligibility prescribed as per the admission notification, the University shall cancel his/her admission at any stage even after admission.
2. Candidates shall have to abide by all Rules/Regulations of the University.
3. The University reserves the right to make changes in the Guidelines, Fee-Structure or any other information any time without prior notice. The decision of the University shall be binding on all.
4. All disputes in relation to the matters pertaining to admission to any of the above courses of the University shall be subject to the jurisdiction of Hon'ble Rajasthan High Court, Jaipur Bench only and not at any other place.
