The candidates who have qualified the Entrance Test, as above, are required to appear for counseling before the Admission Board on Friday, **April 25, 2025** as per the below mentioned schedule. They shall be considered for admission category-wise, as per the reservation policy of the State Government strictly in accordance with the merit.

No separate intimation will be given to the candidates about their result and counselling schedule.

As per the Admission Notification dated February 24, 2025, if a candidate has appeared in National level common any entrance exam i.e. PG/CAT/MAT/CMAT/XAT/NMAT/ATMA/GMAT/SNAP/IIFT/IBSAT/PIM-MAT/GPAT; he is exempted to appear in Entrance test of the MGUMST. The scores of national level common entrance examination shall be accepted for admission to the MHA program. The test scores should not be more than a year old on the date of MGUMST entrance test. Such candidates are required to appear for counseling before the Admission Board on Friday, April 25, 2025 as per the below mentioned schedule. They shall be considered for admission category-wise, as per the reservation policy of the State Government strictly in accordance with the merit.

Important:

- 1. Before coming to attend the counseling, candidates are advised to self-check and ensure their eligibility as given in the Admission Notification dated February 24, 2025. Candidates who do not fulfill the eligibility shall not be allowed to appear before the Admission Board for the counseling.
- 2. Candidates whose results of the graduate level qualifying examination are still awaited, shall also not be allowed to appear before the Admission Board.
- 3. Following relevant Original documents and one set of self-attested photocopy of the documents are to be brought by the candidate at the time of Counseling otherwise the candidate shall not be allowed for the Counseling:
 - Marks sheet/Certificate of the Secondary Examination (10th Class) showing date of birth.
 - Marks sheet of 10+2 (Senior Secondary) or its equivalent Examination.
 - Marks sheet of qualifying examination, as applicable (as mentioned in the "eligibility" column of the notification dated February 24, 2025)
 - Transfer Certificate from the Institute last attended.
 - Character Certificate from the Head of the Institute last attended.
 - Valid Caste Certificate for Reservation Category (EWS/SC/ST/OBC-NCL/MBC-NCL etc.) if category is other than General Category.
 - Internship completion certificate, if applicable
 - Domicile Certificate & Aadhar Card
 - Disability Certificate, if applicable.
 - No objection certification/permission from the present employer for MHA regular full-time program (for in service candidate only).
 - Score card of the common entrance examination already qualified at State / National for admission to MHA, If applicable.
 - Migration Certificate from the concerned Board/University (in case the University is other than the MGUMST).
 - Other relevant certificate(s), if any.

The candidate selected for provisional admission through MGUMST entrance test shall be required to deposit Rs. 3,12,500/- (Tuition Fees Rs. 2.50 Lacs, Caution Money Rs. 30,000/-, Enrolment Fees Rs. 25000/- and Eligibility Fees Rs. 7500/-) up to May 02, 2025 through RTGS in the University Bank Account.

The candidate selected for provisional admission through national level common entrance examination as mentioned above shall be required to deposit Rs. 3,13,500/- (Tuition Fees Rs. 2.50 Lacs, Caution Money Rs. 30,000/-, Enrolment Fees Rs. 25000/-, Eligibility Fees Rs. 7500/- and Admission Charges Rs. 1000/-) up to May 02, 2025 through RTGS in the University Bank Account.

Proof of deposition of above amount along with one post-dated cheque (dated 01.04.2026) of Rs. 2.50 Lacs in favour of Mahatma Gandhi University of Medical Sciences and Technology, Jaipur for the remaining one-year course duration tuition fees will be required to be submitted in the Admission and Career Counseling Cell, MGUMST latest by May 02, 2025.

Candidates already enrolled with the Mahatma Gandhi University of Medical Sciences and Technology, Jaipur need no fresh enrolment. Others shall submit migration certificate upto July 31, 2025 for enrolment else late fee for submitting Migration Certificate shall be applicable.

The Admission Board shall verify all the original documents of the candidates and shall issue provisional admission letters to suitable candidates.

No extension in the last date of deposition of fees/postdated cheque shall be granted in any case.

In case a candidate does not deposit fees and postdated cheque in time, provisional admission granted to the candidate shall stand cancelled.

Required Undertakings/Declarations/Affidavits etc. by the candidate and/or parent shall be submitted in the office of the **Principal**, **Mahatma Gandhi College of Hospital Administration** before the date of **the start of the session 2025-26**.

Undertakings/Declarations/Affidavits shall be submitted by the candidate and/or parent regarding Anti Ragging as per UGC guidelines / regulations.

Registration:

Candidates admitted to MHA program shall also submit online Registration form alongwith prescribed fee Rs. 7000/- within two months of commencement of the program else late fee shall be applicable.

NOTE:

- 1. In case, it is found that a candidate does not fulfill the conditions of eligibility prescribed as per the Notification/Rules, the University shall cancel his/her admission at any stage.
- 2. Candidates shall have to abide by all rules/regulations of the University.



- 3. The University reserves the right to make changes in the Guidelines/Rules at any time. The decision of the University shall be binding on all.
- 4. All disputes in relation to the matters pertaining to admission shall be subject to the jurisdiction of Hon'ble Rajasthan High Court, Jaipur Bench only and not at any other place.
