Reservation of seats for admission will be made as per the Reservation Policy of Rajasthan Government. Candidates belonging to other states shall be considered in General Category.

Important:

1. Candidates, **who has domicile of Rajasthan shall be eligible for registration with the Rajasthan State Allied and Healthcare Council** as per the Gazette Notification dated February 16, 2023 of Medical and Health Department, Government of Rajasthan Regulation 42 of the Rajasthan Para-medical Council (Amendment) Regulation, 2023.

2. Before coming to attend the counseling, candidates are advised to self-check and ensure their eligibility in all respects for admission to the course they have applied for. Candidates who do not fulfill the eligibility and also candidates whose results of the qualifying examination are still awaited, shall not be allowed to appear before the Admission Board.

3. Following relevant Original documents and one set of self-attested photocopy of the documents must be brought by the candidate at the time of Counseling otherwise the candidate shall not be allowed for the Counseling:

- Marks sheet/ Certificate of the Secondary Examination (10th Class) showing date of birth.
- Marks sheet of 10+2 (Senior Secondary) or its equivalent Examination.
- Transfer Certificate from the School/Institute last attended.
- Character Certificate from the Head of the Institute last attended.
- Valid Certificate for Reservation Category (EWS/ SC/ ST/ OBC- NCL/ MBC- NCL etc.) if category is other than General Category.
- Domicile Certificate and copy of Aadhaar Card
- Disability Certificate, if applicable.
- Migration Certificate from the concerned Board/University (in case the University is other than the MGUMST).
- Other relevant certificate(s), if any.

The Admission Board shall interact with the candidates and grant provisional admission. Candidates found eligible for provisional admission by the Admission Board shall be given Provisional Admission Letter. Fees and/or postdated cheque(s) as mentioned in the Provisional Admission Letter will have to be deposited by the candidate latest by 15/10/2025.

In case a candidate does not deposit fees and/or postdated cheque(s) in time, provisional admission granted to the candidate shall stand cancelled and next candidate in the waiting list shall be offered admission.

No extension in the last date of deposition of fees/postdated cheque(s) shall be granted in any case.

Required Undertakings/Declarations/Affidavits etc. shall be submitted by the candidate in the Admission and Career Counseling Cell Latest by **October 16, 2025**.

NOTE

1. In case, it is found that a candidate does not fulfill the conditions of eligibility prescribed as per the admission notification, the University shall cancel his/her admission at any stage.
2. Candidates shall have to abide by **all rules/regulations** of the University.
3. The University reserves the right to make changes in the Guidelines, Fee-Structure or any other information at any time without prior notice. The decision of the University shall be binding on all.
4. All disputes in relation to the matters pertaining to admission to any of the courses of the University shall be subject to the jurisdiction of Hon'ble Rajasthan High Court, Jaipur Bench only and not at any other place.
