Before coming to attend the Interaction/ Viva-Voce, candidates shall have to self-check and ensure their eligibility for Ph.D. program in all respects. Candidates who do not fulfill the eligibility shall not be allowed for the Interaction/Viva-Voce.

Following relevant Original documents and one set of self-attested photocopy of the documents are to be brought by the candidate at the time of Interaction/Viva-Voce. Candidates who do not bring all the required original documents shall not be considered for Interaction/Viva-Voce in any case. Candidates whose results of the qualifying examination are still awaited, shall also not be allowed for Interaction/Viva-Voce:

- 10<sup>th</sup> Class marks sheet/ certificate of the secondary examination showing date of birth.
- 12<sup>th</sup> Class (Senior Secondary) marks sheet or its equivalent examination.
- Marks sheets of UG degree qualification.
- Mark sheets of PG degree qualification
- Transfer Certificate from the college/ institution last attended.
- Character Certificate from the college/ institution last attended.
- Valid Certificate of the reservation category in respect of EWS/ SC/ ST/ OBC- NCL/ MBC-NCL etc. except General Candidates. Candidates domiciled in states other than Rajasthan shall be considered in General Category.
- Domicile Certificate & Aadhar Card.
- Disability Certificate, wherever applicable.
- Candidates are required to bring the following employment related documents -
  - **For Full Time Candidates only** – Required to submit Declaration of Non-Employment (Annexure 1).
  - **For Part Time Ph.D. (External Candidates)** – Required to submit No Objection Certificate from Employer (Annexure 2).

#### Criteria for Selection:

A weightage of 70% for the written entrance test and 30% for the performance in the Interaction/Viva-Voce shall be awarded.

The PhD Admission Board shall take into account performance of the candidate both in written entrance test and Interaction/viva-voce for his/her selection to Ph.D. program. Candidates found suitable for admission in all respect shall be issued provisional admission letter.

#### Fees Deposition:

Candidates selected by the PhD Admission Board for admission to Ph.D. program shall be required to deposit Ph.D. program fee as under:

Candidates selected by the PhD Admission Board for provisional admission to Ph.D. program shall be required to deposit Ph.D. course fee, two/ three post-dated cheques and caution money as above latest by **Friday, January 30, 2026 or on the date as mentioned in the Provisional Admission Letter** in University Bank account through payment link which will be sent to the selected candidates on their registered email.

After deposition of tuition fees and caution money by the selected candidates, they will report to the Principal of the concerned college and to the Head of the concerned department on the date as mentioned in the Provisional Admission Letter. Required Undertakings/ Declarations/ Affidavits etc. shall be submitted by the provisionally admitted candidates and their parents in the office of the Principal of the concerned college at the time of reporting.

#### Note:

- Even after the admission, if it is found that a candidate does not fulfill the conditions of eligibility prescribed as per the Notification/Rules, the University shall cancel his/her admission at any stage.
- Candidates shall have to abide by all the rules/regulations of the University.
- In case, a candidate discontinues the course after the admission on any account, the fees deposited by him/her shall be forfeited.
- The University reserves the right to make changes in the Guidelines, Fee-Structure or any other information at any time without prior notice. The decision of the University shall be binding on all.
- All disputes in relation to the matters pertaining to admission shall be subject to the jurisdiction of Hon'ble Rajasthan High Court, Jaipur Bench only and not at any other place.
